

Yoga Teacher Training Terms and Conditions

1.0 PAYMENT POLICY

- Once you have been accepted into the course, a \$500 non-refundable deposit will be required with the completion of this signed contract.
- Full payment will be due a minimum of 7 days prior to the commencement of your training start date and participants agree to pay any outstanding balance no later than this date unless a payment plan has been authorised by the TotalFusion National Program Director.

If a payment plan has been offered, you will be required to make fortnightly payments, the sum of the fortnightly payment will be dependent on the duration of the course and course total fee. The payment plan must be finalised before the conclusion of the training. Failure to complete the payment will result in no qualification.

2.0 REFUND POLICY

If a student withdraws from the TotalFusion training, the following refund policy applies:

- If the student withdraws 7 days or more prior to course commencement the student will receive a full refund minus the non-refundable deposit of \$500. The value of the training course can be used as a credit note or transferred to membership.

- If the student withdraws 1 – 6 days prior to the course commencement, the student will receive 50% of the full course fee, minus the non-refundable deposit of \$500. If the student is on a payment plan, they will receive 50% of what has been paid to TotalFusion minus the \$500 deposit. The value of the training course can be used as a credit note for future training or transferred to membership.
- If the student withdraws once the training has commenced or on the day the training commences, the student will forfeit their right to a refund and any money paid is non-refundable.

3.0 WITHDRAWAL POLICY

If you wish to withdrawal from the TotalFusionTeacher Training, you must provide written notice to kerri@totalfusion.com.au

If you are unable to complete the required hours due to a medical emergency, prolonged illness, death in the family or other extenuating circumstance (To be decided at the discretion of the TotalFusion National Program Director) the student may be granted an extension of time to complete the training within a 18 month period if applicable within the TotalFusion Teacher Training calendar.

If a student misses more than five consecutive training days, the student will be considered withdrawn. This action is at the discretion of the TotalFusion National Program Director.

Any certifications that result out of course completion will not be awarded until all programs requirements have been satisfied.

4.0 ATTENDANCE POLICY

- Students are required to attend 95% of the required training to be deemed satisfactory and be eligible for certification.
- Students who miss more than 95% of the contact hours may request private tuition at their own cost to make up any missed sessions (Costs and scheduling is at the discretion of the TotalFusion National Program Director).
- This course is competency-based. As such, students are able to repeat their assessment until they are deemed competent and meet the requirements for certification (6-month lapse).
- Late arrival and early departure contribute to non-attendance and may affect your required hours.

5.0 MEDICAL CONDITIONS AND RISKS

All students are required to complete the Teacher Training form before commencing the course. Students must complete this form to include any medical conditions or health risks, this form will be a confidential medical disclosure document.

6.0 CANCELLATIONS

TotalFusion reserves the right to cancel retreats, training and programs at any time for any reason, and its liability shall be limited to a refund in full of funds received by TotalFusion on behalf of the student.

7.0 INTELLECTUAL PROPERTY

All course material is copyrighted and protected by Australian intellectual property law. Students who enrol and complete any training with TotalFusion do not own the rights to any TotalFusion content and agree to not copy, distribute or share TotalFusions' intellectual property.

- Students are authorised to print content for their own study, however, are not able to share or distribute any course content.
