

## TotalFusion Signature Add-On Terms and Conditions

### 1. Signature Add-On

- 1.1 These are the Terms and Conditions (**T&Cs**) that apply to the TotalFusion Signature Add-On (**Signature Add-On**). These T&Cs should be read in conjunction with the TotalFusion Membership Terms and Conditions and Membership Rules.
- 1.2 The Signature Add-On requires both a valid Membership Agreement and either a Membership or Add-On that entitles the Member to access the designated Wellness area.
- 1.3 The Signature Add-On allows Members to access our Wellness Modalities such as Cryotherapy, Red Light Therapy or PEMF Therapy for an addition fee (**Add-On Fee**).
- 1.4 The Add-On Fee is \$30 per week and charged fortnightly on the same schedule as the Members Membership Fees
- 1.5 The access to these modalities is done in the form of a credit system that entitles the member to use these credits to access the services.
- 1.6 A Wellness Credit can be redeemed for the following services (where available):
  - o Cryotherapy
  - o Red Light (10 Min Session)
  - o PEMF (15 min Session)
  - o Private IR Sauna (30 Min Session)
  - o Private LED Session and Curtain Bed (15 Min Session)
  - o HBOT (45 Min Session)
  - o HOCAT (30 Min Session)
- 1.7 The Signature Add-On entitles the member to 6 Wellness Credits per fortnight (allocated on the date the member makes a successful payment).
- 1.8 If the Wellness Credits are not used within the fortnight (Add-On Entitlement Period) the credits expire. I.E the Credits do not accumulate.
- 1.9 Credits are non-transferable.

- 1.10 The Signature Add-On entitles a member to purchase additional Wellness Credits at a discount to the price for other members.
- 1.11 The inclusions and availability of Wellness Modalities depends on the TotalFusion club and is subject to change. Please enquire with the Reception team to confirm the Modalities available.

### 2. Including and Cancelling the Add-On

- 2.1 Membership Add-Ons are charged on a fortnightly basis as a prepayment for services included with the Membership Add-On for the fortnightly period in advance of the payment (**Add-On Entitlement Period**).
- 2.2 To include the add-on to the Members membership a member may nominate to add this to their membership during their Membership Application or may request the add-on is included in their membership by requesting in writing.
- 2.3 Once the Member has included the Add-On to their membership, TotalFusion will continue to charge the Member the Add-On fee until we have received a cancellation request from the Member.
- 2.4 There is no minimum commitment period for a Membership Add-On and members can cancel a Membership Add-On at any time by sending a request in writing.
- 2.5 Once TotalFusion receives a cancellation request this will be processed at the end of the Members Add-On Entitlement period so the Member will not be charged the Add-On Fee again but will be able to access the reformer & run club studios until the end of their applicable Add-On Entitlement Period.
- 2.6 If the Members nominated payment method has been charged at the time of receiving the cancellation request, then the cancellation will be processed at the end of the next Add-On Entitlement Period.
- 2.7 TotalFusion will not backdate an Add-On cancellation request.

- 2.8 If the Member suspends their Membership, the Add-On will automatically be cancelled for the period the Member is on suspension.

**3. General**

- 3.1 The Add-On is only available to the Member in the nominated Club in the Members Membership Agreement.
- 3.2 There will be no refunds if a member is in default and unable to access the services.
- 3.3 The T&Cs of the Add-On are subject to change. If a change to the T&C materially impacts the Member they are entitled to cancel the Add-On at the date of change for no cost.
- 3.4 Unless otherwise stated, all fees and taxes are stated in Australian Dollars.
